

Instructions for Completing the Form for Value Added Tax Registration for Non-Residents (P.P.01.9)


For verification, the VES system will send an OTP to your business email address through our auto-response email address ves.noreply@rd.go.th. You should enter the OTP received to verify your business email address.



Set password


Your password must meet the following requirements:

- 1) Must contain at least 8 characters but no more than 30 characters.
- 2) Must contain English characters and number.
- 3) Must contain at least one number.
- 4) Must contain at least one uppercase English character.
- 5) Cannot use the word "password".



Complete registration

1) After setting the password, you can review your VAT registration information.



- 2) Please make sure that you have completed all information.
 - If you wish to submit the VAT registration application, please click "Submit Form".
 - If you wish to change your information in the VAT registration application, please click "Edit Form". You can edit your registration information until 11:59:59PM (Thai local time) on the date that you submit the VAT registration application. After that time, if you wish to change your registration information, please notify the change at ves@rd.go.th. However, after the Revenue Department has announced and listed you as a VAT registrant on the Revenue Department's website, if you wish to change essential particulars in your registration (your name or your business email address or your business website), please submit the P.P.09.9 form via the VES system. If you wish to change other information, please notify the change at ves@rd.go.th.

Please carefully review your information. After you submit this form, you will have until midnight of today GMT+7 (Bangkok Time) to make any additional edits. After that time, your company will be listed on our official VAT registrant page. To make additional changes in the VAT operator's name, business email address, and business website after that time, you are required to file a request (P.P.09.9 Form). To make other additional changes after that time, please send an email to the email address that the Revenue Department provides.

Terms and conditions for the use of the VAT for Electronic Service (VES), which is a computer network system of the Revenue Department of Thailand that is hereinafter referred to as "Service Provider" of the VES, of the entity requesting to use the VES which is referred to as "Service User". The service user agrees to be bound by and comply with the terms and conditions governed by the provisions in the Revenue Code regarding value added tax obligations related to the VES of non-resident service providers and electronic platforms for electronic services provided to non-VAT registered service recipients in Thailand. - If you do not agree to the terms and conditions, please click "Reject and Cancel".


13. The service provider reserves the right to immediately suspend or cancel the provision of service to the service user if there is evidence that the service user does not comply with any of these terms and conditions.




